### **Class B Pathogen Reduction**

40 CFR part 503 and Arizona Administrative Code R18-9-1006-E (5) Class B pathogen reduction requirements were not met via anaerobic digestion as multiple digesters detention times fell below 15 days. NO biosolids were land applied from Plant No. 1. All biosolids from Plant No. 1 were shipped to a compost facility for further treatment to meet Class A pathogen reduction requirements, or sent to a municipal landfill.
