Dear Representative Kim:

On behalf of the Orange County Sanitation District (OC San), I write to request your support of an important clean water community project. Specifically, OC San is proceeding to undertake an ambitious construction project known as the Headworks Rehabilitation Project at Plant No. 1. This project will ensure the long-term sustainability of critical public health and environmental services, including affordable wastewater services to disadvantaged communities within the OC San service area.

OC San provides wastewater collection, treatment, and recycling for approximately 2.6 million people in central and northwest Orange County, CA. OC San’s primary mission is to protect public health and the environment through its services.

We hope that you will communicate your support of this community project for federal assistance as Congress develops the Fiscal Year 2022 appropriations bill for the U.S. Environmental Protection Agency (USEPA). OC San is seeking \$10,000,000 as part of the Fiscal Year 2022 appropriations through the USEPA.

The proposed project would modernize the removal of inorganic pollutants, sanitary products and other large materials before OC San can treat the wastewater that is then relied upon as the feedstock for recycled water supply that is vital to Orange County’s drought security to produce a resilient water supply. The project has the added benefits of increasing the efficiency of the treatment process, reducing air emissions and odors, and continue efforts to safeguard fence line communities. Project construction is scheduled to commence in the summer of 2021. The total construction cost of the project is \$222,000,000.

OC San understands that the House Committee on Appropriations has requested that Members submit requests for Community Project Assistance as part of the fiscal year 2022 appropriations process. The enclosed information details the Headworks Rehabilitation Project. The project is, under the Committee on Appropriations’ guidelines, eligible for community project assistance. OC San seeks federal assistance through the Interior, Environment and Related Agencies Appropriations bill and specifically under USEPA’s State and Tribal Assistance Grants Account; Clean Water State Revolving Fund (SRF).
